WHEREAS, the Pahrump Town Board of the unincorporated Town of Pahrump finds that the final assessment for the Debt Service of the unincorporated Town of Pahrump has been made on the 1985-1986 tax rolls; and

WHEREAS, the Pahrump Town Board of the unincorporated Town of Pahrump finds that the monies collected are short ONE HUNDRED FORTY ONE DOLLARS AND FIFTY CENTS, (\$141.50) of paying the Debt Service in full;

DEVELOPMENT COUNCIL AS REPRESENTATIVES  
OF THE UNINCORPORATED TOWNSHIP OF PAHRUMP
